# **CUB TO OPPOSE NW NATURAL RATE HIKE**

NW Natural, Oregon's largest natural gas utility has asked the PUC to allow it to raise residential rates by 9%. The rate increase is unrelated to the cost of natural gas. Instead it relates to employee costs, shareholder profits, company overhead, billing and distribution costs.

When NW Natural was proposing to buy PGE last year, it said that these costs would be frozen for the next 6 years. "What has changed?" asked Bob Jenks, CUB Executive Director.

"Maybe the company sees the PUC granting increases to PGE and Pacific Power, and NW Natural decided they want their increase too."

CUB's initial analysis of their rate request raises a series of troubling issues.

**Fairness.** The company is proposing to raise rates to residential customers by 9%, while at the same time pledging no increase to industrial customers. CUB believes that if cost are really increasing (something we question) then all customers should pay their share.

Ecomonic Development costs. The company is including costs associated with bringing natural gas service to Coos Bay. The company admits that that this service is not economic, but natural gas service in Coos Bay will help with local economic development. CUB does not oppose eco-

nomic development, but there is no authority under state law to tax customers throughout the state for economic development in a single community. Oregon has several economic development programs. Utility rates are not supposed to be used to subsidize economic development.

**Gas Storage.** The company is working to increase the amount of natural gas it stores underground. While gas storage has the potential

to keep rates down, NWN documents make clear that "excess storage" is used for unregulated natural gas trading. This is an activity that benefits shareholders not ratepayers.

It's clear that the company does not deserve an increase of this size.

**Cost of Capital.** 

Since the company's last rate case the cost of capital (borrowing money) has fallen throughout the economy – from home mortgages to government bonds. Yet, NW Natural is asking the Commission to ignore this and grant them a sizable increase in their cost of capital.

It's clear that the company does not deserve an increase of this size. Over the next few months, CUB will be investing a significant amount of resources into analyzing an responding to this filing and working to ensure that Natural Gas rate do not show a significant increase.

# **CUB Works With Domestic Violence Groups For Phone Protections**

Survivors of domestic violence face so many obstacles even after leaving the abusive relationship, maintaining phone service shouldn't be one of them. The Domestic Violence Council (DVC), a group working with domestic violence survivors in Lane County, found that often survivors had difficulty getting phone service in their own name or were hobbled by outstanding balances from accounts they'd shared with a former partner. Yet phone service is so important for safety reasons for these survivors.

The staff and volunteers at DVC propose giving domestic violence survivors certificates like those given to people with medical conditions that require access to phone service. The phone company is prohibited from shutting off service to customers with medical certificates. DVC believes a certification process like the one used for medical certificates could be established and would make a huge difference. CUB will work with the council to create a system and pass legislation to make this happen during this legislative session. # **Eugene and Lane County Ratepayers Get An Easy Way To Join CUB**

When CUB was created by Oregon voters in 1984, the initiative included a funding mechanism that required private utilities to allow inserts in bills inviting ratepayers to join CUB. Every ratepayer in Oregon served by private utilities would have the opportunity to join. Unfortunately, the utilities sued over the requirement and won. The courts ruled that Oregon cannot require utilities to provide ratepayers with information about CUB. CUB has never had the chance to take advantage of this easy and inexpensive way to get information to ratepayers across the state about all CUB can and does do to represent ratepayers.

But fortunately, there are public utilities that recognize it's important for consumers to be able to fund their own representation in front of the Public Utility Commission and in the legislature. The Eugene Water and Electric Board (EWEB) and the Emerald People's Utility District (EPUD), which serves rural Lane County, have agreed to put a CUB insert in their bills in early 2003.

The inserts will be in EPUD bills in January and February 2003. EWEB will include inserts sometime in the first half of the year. Over 100,000 Oregonians will have the opportunity to join CUB and make sure that residential ratepayers have a voice at the PUC and in the legislature. CUB members can help out by encouraging friends and family who live in Lane County to join CUB when they get the insert. CUB members who are served by EWEB and EPUD can contact their board members and thank them for helping consumers.

# **CUB Continues To Be Concerned About A Pro-Utility Commission**

Last summer, the Oregon Public Utility Commission (PUC) handed down a ruling granting PacifiCorp a \$131 million rate increase, despite CUB and the industrial customer groups demonstrating that the utility did not deserve the rate hike. It was the last straw in a series of decisions spanning more than a year where the PUC has favored utility interests at the expense of ratepayers. CUB is appealing this decision right now in state courts, but that's only one of many steps CUB is planning to take to make the Commission is more responsive to the customers in Oregon and not the utilities.

CUB has been strongly critical of the PUC for the past year, demanding more attention to ratepayers. "The role of the PUC is to protect consumers against the power of monopoly utilities," noted Bob Jenks, CUB's executive director. "It is not clear that the current commissioners have taken that mission to heart."

As reported in CUB's last newsletter, CUB will be taking its case to the 2003 legislature to strengthen the consumers' hand in the ratemaking process. "There seems to be some doubt at the Commission about the authority the commissioners have to protect consumers," said Jenks. "If it takes an explicit legislative directive to define that authority, that's what we'll get." For example, the commission decided last year that it did not have the authority to consider 'rate shock' (the impact that a large increase will have on customers). Let's give them that authority and demand that they use it.

The 2003 legislative session starts on January 13, 2003. CUB will be there from day one to make sure that both the PUC and the utilities are accountable to consumers. # **CUB Keeps The Public Power Pressure On PGE**

Portland General Electric (PGE) is Oregon's largest electric utility and its future owner remains in doubt. Since Enron, PGE's parent company declared bankruptcy and Enron's creditors announced that PGE would be put on the auction block, CUB has worked to make sure PGE's customers are protected. CUB supports a purchase by local government to make PGE accountable to PGE's ratepayers. Since PGE will be sold and ratepayers will be asked to pay back the cost of the purchase we ought to become the owners of the utility.

Once purchased by a local government, PGE would have lower borrowing costs, no federal income taxes and no shareholders demanding profits from ratepayers. This will lead to lower rates.

The City of Portland has stepped up to the plate and is pursuing purchasing PGE. CUB

has supported that effort while working to ensure that the day to day management and operation of PGE as public power entity would be done on a regional basis. CUB has been working with elected officials throughout PGE's service territory and other customer groups to keep these discussions on track.

Since our last newsletter, Portland officials announced that they had hired Goldman Sachs, an investment banking firm, to coordinate a sale of public revenue bonds to fund the purchase. CUB is encouraged by this next step in the process of making PGE public and protecting ratepayers. Depending on the progress of Enron's auction process, Oregonians should know the winning bidder for PGE in the first three months of 2003. Watch this space for more developments.
