Portland Utility Oversight Blue Ribbon Commission And CUB Want To Hear From You!

The Portland Utility Oversight Blue Ribbon Commission has launched, and CUB will provide a phone briefing on how to get involved on Wednesday, October 8th. (See details on flip side for joining with other CUB members to get involved.)

The Commission was formed by Mayor Charlie Hales and Commissioner Nick Fish to develop oversight and accountability reforms regarding how the City Council and its public utility agencies set rates. Streamlining communications and improved transparency are also priority topics.

Janice Thompson, CUB's advocate for residential customers of the Portland Water Bureau and the Bureau of Environmental Services that manages stormwater and sewers, is on the twelve-member group. Other members are from a range of business and public sector interests, including several with utility experience. The Blue Ribbon Commission began in mid-July, and will hold a public hearing on draft recommendations on Thursday, October 16th from 6:00 to 8:30 pm in Room C in the Portland Building at 1120 SW 5th Ave. The Commission will present final recommendations to the Portland City Council in mid-November.

Since its launch, the Blue Ribbon Commission has received briefings by the Bureau of Environmental Services and the Water Bureau that were chock full of budget data, information about public assets including miles of water and sewer pipes, and descriptions of environmental regulations and their impact on utility rates. The Commission also learned about the national reputation of Portland's utility bureaus includina having very good bond ratings, which is like you havina a good credit rating.

CUB's own Janice Thompson gave a presentation on elements of effective oversight of utility policy, budget development, and the rate-setting process. This and presentations on other decision-making models prompted a vigorous discussion of options for improvements to ensure more independent analysis and advocacy.

Reward Yourself



Your Portland utility bill pays for water, sewer, and stormwater management services provided by the Water Bureau and the Bureau of

Environmental Services. On an average residential bill, about 1/3 of the charge pays for water and 2/3 pays for sewer and stormwater management.

The Clean River Rewards program reduces the stormwater charge on your residential bill if **you can manage stormwater runoff from your roof.**

You can register online and see if you are eligible for this program at www.CleanRiverRewards.com. Or download an application form from that website, fill it out and mail in. You can also call 503-823-1371 to have an application form mailed to you. Someone at that number can also answer your questions about the Clean River Rewards program and what it can do to reduce your bill.
